LABOR & EMPLOYMENT

- Waste management Black employee was subjected to racial harassment when a noose was placed in his work area.
- Former Oracle sales leader was terminated in retaliation for reporting and objecting to unequal pay for employees of Indian ethnicity
- Property manager with good performance record was fired during pregnancy leave after company claimed fraud
- Long-term employee of a large bank was terminated based on age after participating in a PIP program

PERSONAL INJURY & MARITIME

- Wrongful death of a 40-year old man on his honeymoon in Hawaii after sliding off a tube towed by a jet ski, two of three insurers denied coverage
- During tie-up operations of cargo vessel in Oakland, long-term longshoreman experienced career-ending ruptured disc when line was jerked while he was handling it
- Passenger injured during emergency landing of Asiana flight at SF Airport
- Passenger of small craft injured during emergency landing in field (Declaratory Relief)

CIVIL RIGHTS

- Police Officer kicked and dragged a petite Latina mom during car search with kids in car, bystander video shown on the evening news
- Police Officer tased and arrested plaintiff when he protested the beating of his uncle. Plaintiff acquitted following resisting arrest trial
- County Jail prisoner was denied medication and became agitated, was subjected to forceful removal from cell and placed in solitary
- Police Officers detained and arrested Plaintiff (not the subject of search) in his home when officers executed a probation search of home

CONTRACTS & INSURANCE

- National law firm sued cyber security firm after security breach resulting in \$8M ransom demand to not release client files
- Wrongful death of infant when truck failed to stop and rolled over car, insurer claim exclusion applied
- After a fire consumed home, the Named Insured told the insurer that the "tenants" were family members entitled to insurance proceeds
- Government contractor withheld payments from its vendor after delays in job resulted in the contractor's loss of approved status
